Unit-Based Pricing in Al Integration

Description

As AI technologies become integral to business operations, understanding and implementing unit-based pricing models is crucial for optimizing cost efficiency and scalability. This project study aims to explore unit-based pricing strategies, focusing on AI integration within insurance processes. By evaluating initial and ongoing costs, and comparing different AI deployment options, the study seeks to provide insights into effective pricing models that balance cost per transaction, flexibility, data privacy, and regulatory compliance.

Goal

To develop a comprehensive framework for unit-based pricing in AI applications, enabling organizations to make informed decisions about cost-effective AI integration strategies.

Your task

- Understand as-is in interviews with leadership of Allianz Services Chief Transformation Officer area.
- Conduct a literature review of academic and industry reports on unit-based pricing models.
- Evaluate AI deployment options (commercial API, self-hosted LLM, insurtech-focused solutions) based on cost per transaction.
- Create simulations and scenarios of unit-based pricing, hybrid models (fixed amount + unit-based) or alternative models for pricing of AI-based automation solutions based on assumptions
- Develop spreadsheet models to analyze pricing scenarios and validate cost assumptions.
- Synthesize findings into a decision framework to guide adoption choices and ROI projections.
